The Hunger Network of Greater Cleveland is incorporated under the laws of the State of Ohio as a not-for-profit corporation. The organization offers two distinct yet complementary services. Hunger relief goals are met through providing operating support to 82 hunger centers across Cuyahoga County. The hunger centers were supported by approximately 1,900 volunteers during the year which is critical to carrying out our mission. In 2017, hunger centers served 485,313 individuals and 3,952,261 nutritionally balanced meals. Of the clients we served, 30% were children 18 years of age and under while 23% were seniors 60 years of age and older. The organization is designed to maximize limited resources to ensure that those who are hungry have some relief and assistance.

4b (Code:) (Expenses \$ **90,528** including grants of \$) (Revenue \$)

The Stay Well program is a community screening program designed to bridge the gap between hunger and health. In 2017, the program was offered at 12 hunger centers; held 92 events; and served 982 individuals. Services include biometric screenings such as blood pressure, blood glucose, cholesterol, BMI, and body fat percentage. The most frequent screening was blood pressure at 1,439 total screens, followed by blood glucose (1,315) and BMI (1,200). The total number of services was 5,414. Participant demographics show that 64% were female; 36% male. Additionally, the majority were between the ages of 46-60 (37%) and 57% were African American. A typical program session includes screening services provided by medical, physician assistant, pharmacy, and public health dietetic

Screening stations are set up, with separate stations for dietetic education, HIV screening, and medical navigation. Healthy food demonstrations and recipe cards using pantry products are available as well. The program includes extra education topics and services such as mental health and the benefits of flu shots.

Key to this work are the partnerships, of note with University Hospitals' Department of Family Medicine and Community Health for screening support, Case Western Reserve University School of Medicine for a variety of
